Dear Sisters,

By the authority invested in me as Ohio Department President, I order the following:

The 134th Ohio Department Encampment of the Auxiliary to Sons of Union Veterans of the Civil War will be held on Saturday June13, 2020, via ZOOM to begin at 10:00 AM Eastern Standard Time.

This decision was made during a conference call on May 19,2020, beginning at 8:00 PM with our Ohio Department Council unanimously voting that for this year (and this year only) due to the Covid 19 virus, the age of the majority of our Sisters and the health issues that several of our Members are facing, that it would be the best option.

The Council further voted to purchase the ZOOM program for the entire year, in hopes that we can utilize it for local as well as Department meetings when travel, weather and virus might impede our participation.

The following rules will still be in place for this Encampment:

1. OHIO whites will be the "uniform of the day" and each Sister in attendance should plan on wearing a white top. Skirts and pants will not matter since they will not be seen.
2. Badges will still be worn over your heart. Please remember that Auxiliary Sisters only wear one badge and that is always your highest honor.
3. Registration/Credentials is enclosed in this mailing. Each Sister is asked to enclose a \$10.00 check made payable to the Ohio Department ASUVCW. This is a change from what we normally do, but again was voted by Council; \$5.00 to pay for your registration and \$5.00 to serve as

Please remember to sign your registration as this will serve as the "sign in" we normally do the day of Encampment. Please remember that this change is only for this Encampment.
